


# Academic Partnerships: Making Learning Global

To further refine their expertise, students can choose to specialise in one of four areas: constitutional law, criminal law, international law & human rights, or business law. This specialisation allows for a deeper exploration of their chosen field, making them well-prepared for their legal careers.

# Ph.D. in Law

This programme lays emphasis on interdisciplinary research, encouraging students to explore innovative and entrepreneurial ideas within their chosen fields of study. Students are guided in the selection of pertinent research topics and guided through the systematic development of their theses, typically spanning 40,000 to 50,000 words.




# Internships & Placement: Paving Pathways to Success




## Bharatiya Chhatra Sansad Empowering Youth for Change


## R.I.D.E. Igniting Innovation and Entrepreneurship
